

iMall Website Privacy Policy

§.1 General Provisions

1. The Data Controller is Me and My Friends S.A. with registered office in Wrocław, ul. Podwale 7/5, entered into the Register of Entrepreneurs under KRS number: 0000393837, kept by the District Court For Wrocław-Fabryczna in Wrocław, 6th Commercial Division Of The National Court Register, Tax Identification Number NIP: 897 177 70 72. Data protection is carried out in accordance with the requirements of the legislation in force, and the data are stored on secure servers.
2. For easier interpretation of this Privacy Policy, the term "User" was replaced by "You", and the term "Data Controller" was replaced by "Us". The term "GDPR" shall mean the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).
3. We respect the right to privacy and take care of data security. Hence, the protocol for the secure transmission of data (SSL) is used for this purpose.
4. Data specified in a form posted on the website shall be handled as confidential data and shall not be visible to unauthorized persons.

§ 2 Data Controller

5. The Service Provider is the controller of data of its customers. This means that if you send your data in any form via the website, we shall process your data, including your first name, last name, email address, phone number, and company name.
6. The personal data are processed:
 - a. in accordance with the personal data protection legislation in force;
 - b. in line with the established Privacy Policy;
 - c. to the extent necessary and for the purposes of establishing a contact;
 - d. to the extent necessary and for the purposes of fulfilling legitimate interests (legally justified purposes), and the processing shall not violate the rights and freedoms of the data subject.
7. Any data subject (in relation to whom we act as data controller) has the right to access to the data, rectify, delete or restrict the processing thereof, the right to raise an objection against the personal data processing, and the right to complain to a national data protection supervisory authority of their choice.
8. A person responsible for data processing oversight designated by the Service Provider can be contacted via e-mail at: kontakt@imall.city.
9. We reserve the right to process your personal data after contract termination or withdrawal of consent to data processing only to the extent necessary to seek redress before the courts or if we are under the obligation to retain such data according to the domestic, EU or international laws.
10. The Service Provider has the right to provide access to User's personal and other data to the authorized entities (such as law enforcement agencies) under the applicable provisions of law.

11. Personal data can be deleted as a result of withdrawal of consent or legally admissible objection against the personal data processing.
12. The Service Provider shall not disclose personal data to any entities other than entities authorized under the applicable provisions of law.
13. We have introduced pseudonymisation, data encryption and access control, thereby minimizing the consequences of possible violation of data safety.
14. Personal data are processed exclusively by persons authorized by us or data processors with whom we closely cooperate.

§3. Cookies

15. The website <https://imall.city/> uses cookies. Cookies are small text files sent by a web server and stored by web browsers. When a browser revisits a website, the website recognizes the user's device used to make the connection. Based on the parameters, the information contained in cookie files are only readable by the server that created them. Cookies help browsing the websites previously visited.
16. Cookies collect information about IP address, type of browser used, language, type of the operating system, internet service provider, information about the time and date, location and information sent to the website via contact form.
17. The data collected are used to monitor and verify how users use our websites in order to streamline the service operation by making the website navigation more effective and safer.
18. The following cookies are used on our website:
 - a. "necessary" cookies which allow you to use the services available as part of the online service, such as verifying cookies used for services requiring authentication;
 - b. "performance" cookies that enable the collection of information about the way the website is used;
 - c. "functional" cookies that allow the 'remembering' of settings selected by the user and customization of the user interface, for example with regard to the language or region of the user, the font size, the layout of the website, etc.
19. Users can deactivate or restore the cookies option by changing the browser settings at any time.
20. Additional personal data, such as e-mail address, are only collected if the user explicitly consents thereto, for example by filling out a form.

Legal note

21. Me and My Friends S.A. (hereinafter referred to as Data Controller) is the controller of the data submitted via forms available at <https://imall.city/>. In all matters related to the personal data provided, please contact the Data Controller at: kontakt@imall.city.
22. No personal data that you supply to the Data Controller shall be provided to third parties. The data can be supplied to other entities that process the data on behalf of the Data Controller and can be contracted by the Data Controller to perform specific technical operations in relation to personal data processing, which shall each time take place on the basis of a personal data processing outsourcing agreement.
23. Personal data shall be either processed to provide a customized offer by the Data Controller or in order to conclude and perform an agreement (in which case the processing of personal data shall be justified by the operations necessary to conclude and perform an agreement) or

to provide a commercial offer according to the inquiry submitted (the processing of personal data shall be based on direct marketing as the legally justified purpose of the Data Controller).

24. In commercial relations, the Data Controller shall process the data for the period necessary for the purposes of the data processing (i.e. essentially in response to an inquiry filed), but not longer than for the period of 6 months from the date of the last contact related to the manner concerned or until the date on which an objection to the personal data processing is filed.
25. You have the right to access, to demand rectification and deletion of data relating to you (the right to be forgotten), to object to data processing, to restrict data processing, and the right to transfer data – this shall not affect the lawfulness of processing before any of these rights are enforced. You have the right to lodge a complaint with a supervisory authority if the method of data processing is deemed to be unlawful.
26. Provision of the personal data is voluntary but essential to draw up a commercial offer by the Data Controller.
